**Moorestown's Environmental  
Resource Inventory (ERI) Explained**

Periodically, townships are called upon to assess and inventory the biotic and abiotic components of the area within their boundaries. Over the years, STEM has worked with Moorestown to help with compiling this critical information. This process is currently underway and a draft document is ready to share with the public.

The purpose of an Environmental Resource Inventory (ERI) is to identify and describe the natural resources of a community. A community's natural resources—its soil, water, air, forests, fields, and waterways—are fundamental to its character. The protection and wise use of those resources is essential to the public health, safety, and welfare of current and future residents.

The ERI provides the basis for the development of methods and steps to preserve, conserve, and utilize those resources, although it does not include specific recommendations to those ends. It is, instead, a compendium of all the existing information that can be found about a township's natural resources, presented in a form that is useful to a broad audience.

The public is encouraged to learn more about the ERI at a public meeting to be held on Saturday, March 23, 2013 at the Moorestown Library beginning at 12:00 p.m. A short presentation will be given by Amy Miller of the Delaware Valley Regional Planning Commission (DVRPC), followed by time for questions and feedback from the public.

## **Is Celebrating Earth Day For the Birds?**

**Find out on Saturday, April 20.**

Please join Mark Pensiero, a local birder and STEM director, who will lead a birding walk at the Boundary Creek Natural Resource Area on Creek Road. This beautiful county park was designed to be both wildlife and people-friendly. It has beautiful trails that run through an old peach orchard, as well as numerous viewing platforms and blinds that look out over tidal marshland and the Rancocas Creek.

In the spring, marsh marigold blooms along the marsh edges. This site can be very good for spring bird migration with several species of warblers, vireos, flycatchers, Baltimore and Orchard Orioles, and Yellow-billed Cuckoo possible. The marsh can be great for resident Swamp Sparrows and Marsh Wrens. Keep your eyes open for Bald Eagles. While the focus is on birds, we'll keep our eyes open for beaver, muskrat, and the occasional River Otter.

We'll meet at the pavilion at 8:00 a.m. and will finish up by 11:00 a.m.. Please bring binoculars. You may also want to pack a lunch—it's a great spot for a picnic. Only a hard rain will cancel the event.

## ***Pompeston Woods Easement Committee: The Annual Monitoring Report***

Three STEM members, Sue Poaletti, Tom Finley, and Claire Rollin Adair, the latter acting as leader, conducted the Committee's annual Pompeston Woods Easement monitoring on the afternoon of December 3, 2012. The trio comprised the last remnants of an original troop of a dozen or more volunteers led by the indomitable Esther Yanai who surveyed, staked, and photographed the Easement over a decade ago. The goal of the group remains the same: to insure that the Easement is kept in its natural state, free from human encroachments.

This year, the team took approximately two hours to inspect all of the fifty-six site points, and then composed a report to distribute to both North Riding Drive residents whose properties abut the Easement, and the two Moorestown West Corporate Center owners whose properties comprise the Easement. The report was divided into three areas, the Easement interior, the North Riding residents' border, and the Corporate Center border. A summary follows.

### ***Plastic Recycling***

Before you toss your plastic bottles with a recycling number higher than 2 into the regular trash, note that they can be recycled at the County Recycling Center in Florence. If you would like to drop them off at a closer venue, try Whole Foods in Marlton.

#### **EASEMENT INTERIOR:**

The interior was generally free from litter and signs of human activity. Several trees had been blown down by Hurricane Sandy, but the flora and fauna seemed intact.

#### **N. RIDING RESIDENTS' BORDER:**

There was a small amount of litter consisting of bottles and plastic bags on some edges of the Easement, and some residents had deposited grass and wood clippings on Easement peripheries, but generally the residents respected the Easement area's restrictions. The post-monitoring letter sent to the neighbors noted their responsibilities and detailed the few violations of the restrictions.

#### **MOORESTOWN WEST CORPORATE CENTER BORDER:**

As has been the case in the past, a large amount of litter in the form of plastic, styrofoam, and paper permeated both the berm just outside the Easement and the Easement itself downhill from the berm. Most of that litter had blown from the dumpsters outside the rear of the buildings. These violations were quickly corrected due to the prompt action of Cort Company's Transporta-

tion Manager, Jerry Herrmann and his staff. The Pompeston Woods Easement Committee spoke to him personally the same day of the monitoring about the litter issue, and he promptly conducted a cleanup of the area. When the Committee reinspected the area one week later, they found both the berm and Easement area free from litter. In addition, Mr. Herrmann stated that he would insure that the violations would not continue in the future.

Next year the Committee hopes to have new members to help with the monitoring task in late November or early December of 2013.

## Percheron Park Update

In 1839, when Moorestown native Edward Harris II introduced the Percheron draft horse to the USA from France, live horsepower was still the main source of energy for farm and hauling work. Railroads and steam-powered sailing ships were in their infancy, and the combustion engine was far in the future. Horses were “it,” and the Percheron horse possessed the characteristics of speed, strength, stamina, spirit, and easy temperament needed to help develop this country. The Percheron outnumbered the other primary draft horse breeds (Belgian, Clydesdale, and Shire) by three to one in America by 1930. The importance of this horse to our country is the reason that Moorestown is naming its newest park in its honor.

Percheron Park is a citizen-inspired-and-led effort and is being funded by private donations. Any amount is appreciated. With all that planting you will be doing this spring, make sure you save some space in your gardens and planting beds to accommodate some of the native varieties that will be on sale on Saturday, June 1, 2013. Visit the STEM table near the First Baptist Church on Main Street during Moorestown Day and contribute not only to the health of the local and migrating wildlife, but also the strength of STEM's finances. The Plant Sale is the organization's only fundraising event of the year.
